21/086	<p>Minutes of previous meeting: RESOLVED that the minutes of the meeting held on 17 January 2022 pages 21014-21015 be confirmed as a true record and signed by Chairman. It was noted that Cllr. Richardson had met with engineers from Highways regarding the noticeboard on the crossroads at Millness. Forms had been completed and returned to Highways. Cllr. Gott entered the meeting</p>
21/087	<p>Declaration of interests: RESOLVED to accept declarations from: Cllrs. Richardson and Clarke regarding item 6c on the agenda Cllrs. Winter and Gott regarding item 5 on the agenda in relation to Sillfield Farm.</p>
21/088	<p>Public Participation:</p> <ol style="list-style-type: none"> a) The police report had been received for February which contained some general information and advice about preventing burglaries which seemed to be on the rise in the area. b) No County or District Councillors were present but they were expected later. c) Janet Batty from Levens PC was in attendance to listen to the meeting.
21/089	<p>Planning: The meeting considered the following applications:</p> <p>SL/2022/0044 at High Bracken Hall, Gatebeck, LA8 0HS - Removal of condition 4 (Occupancy) attached to planning permission SL/2005/0758 (Provision of 13 mobile holiday chalets together with ancillary amenity building and car parking and installation of biological treatment plant and reed bed)</p> <p>RESOLVED that there were no objections to this application</p> <p>SL/2022/0106 at Warth Sutton Farm, Farleton View Fishery, Crooklands, LA7 7NU - Change of use from agricultural land to create 5 touring pitches (Retrospective) & change of use from agricultural land to provide 29 new touring pitches and 4 new pitches for static caravans</p> <p>RESOLVED that there were no objections to this application</p> <p>SL/2021/0630 at From land East of Town House, Old Hutton to land east of Bleabeck Plantation and immediately west of Old Scotch Road, Old Town; with highway works at various locations along Old Scotch Road and Reservoir Road - Proposed works for and use of replacement section of aqueduct, including earthworks and ancillary infrastructure including: a new valve house building within fenced compound with permanent vehicular access provision; installation of tunnel shafts; open cut connection areas at either end of the replacement section within temporary construction compounds, to include site accesses, storage areas, plant and machinery, and drainage infrastructure; and a series of local highway works.</p> <p>Noted that the council had been consulted on this application around 18 months earlier and had noted that the application doesn't affect this parish other than minor roadworks. RESOLVED that there are no objections.</p> <p>SL/2022/0214 at Jakeys Wood, Land to the North East of Warth Fish Pond, Gatebeck, LA8 0HY - Change of use of agricultural land to form a recreational cycle track (Use class use F2 outdoor leisure)</p>

	<p>There was some discussion regarding this application as there were concerns regarding parking, hours of use, noise disturbance, erection of buildings and future development. RESOLVED that there were no objections in principle but that neighbouring properties must be properly consulted and their views taken into consideration. Also, proper consideration needs to be given to parking, planting, hours of use and erection of buildings. Finally it must be a condition of planning that use is restricted to push bikes only.</p> <p>County Councillor Bingham and District Councillor Cooper entered the meeting.</p> <p>Cllrs. Gott and Winter left the meeting.</p> <p>SL/2022/0145 at Sillfield Farm, Gatebeck, LA8 0HZ - Subdivision of approved residential unit plot number 5 (planning permission SL/2020/0966 - Conversion of barns to 5 dwellings) to form 2 dwelling units, and raise eaves height to same as adjoining barn 2.</p> <p>Noted that the previous application had been approved and this was an amendment to sub divide one unit into 2 dwellings. RESOLVED that this amendment does not have any adverse effect on the development and therefore there were no objections.</p> <p>Cllrs. Gott and Winter re-entered the meeting</p>					
21/090	<p>Public Participation continued: Since Cllr. Bingham and Cllr. Copper had arrived late it was agreed to return to item 4b on the agenda. Cllr. Bingham advised that the judicial review into Local Government Reorganisation had failed and that the Structural Changes Order had now been signed. Noted that there had been no increase in Council Tax from either the District Council or the County Council although the Social Care Levy had increased by 2%. The Police and Crime section of Council Tax had been increased by the maximum 9.99% to pay for the extra 143 officers recruited.</p>

Mack who had been on hold for up to 2 hours at a time without answer. Due to these difficulties and the number of cheques that were going missing in the post recently it was recommended that the council change bankers to Unity Trust Bank in order to obtain the facility for online payments. It was RESOLVED to make this change. It was further RESOLVED that Scott Thornley be added to the list of authorised persons for the NS&I Investment Account and that all correspondence be sent to his address.</p> <p>c) A grant application from Preston Patrick Memorial Hall was considered and it was proposed by Cllr. Winter and Clarke had been to inspect the proposed location for planting a tree and it was discovered that this location was not suitable. It was suggested that Gatebeck Crossroads or in the large verge between Sillfield and the motorway bridge and Cllr. Winter agreed to look at these locations. If a representative from the council is required at any meeting regarding the celebrations, Cllr. Winter will attend.</p>

It was questioned whether the .gov.uk domain was a necessary requirement and the clerk will check with CALC. If not then Cllr. Mack will be able to proceed with building the new site with a basic hosting account at a cost of £6.50 per month. No decision made until the clerk has spoken with CALC.
